### **BUILDING ON AN INCREDIBLE LEGACY**

Summer marks a season of change. For CASA of Jefferson and Gilpin Counties, this summer signaled a monumental transition in the organization: Leah Varnell, CASA Jeffco/Gilpin Executive Director, retired after 20 years in the role and 25 years with the organization, and Melissa Hellmuth, former CASA Jeffco/Gilpin Director of Operations, stepped in to lead the next era of the organization.

"What excites me most about leading CASA is the opportunity to build upon the incredible work of Leah, our dedicated board and staff, and the amazing volunteers who have helped shape this organization to what it is," Melissa said.

### New Role, Unwavering Enthusiasm and Experience

Melissa started her nonprofit career with CASA Jeffco/Gilpin, spending 5 years in volunteer recruitment and training and 5 years on our development team. She, her husband Chase, and their daughter Maggie then spent 7 years in Reno, NV where Melissa continued to deepen her experience in nonprofit fund development, donor relations, and nonprofit management with Renown Health Foundation and United Way of Northern Nevada and the Sierra.

Melissa and her family moved back to Colorado in 2024 and she rejoined our organization as Director of Operations.

"With Melissa's background, she was well-equipped to hit the ground running," said Laurie Burkhart, CASA Jeffco/Gilpin Board Chair. "Add to that her enthusiasm for the organization's purpose, her contagious energy, and her fresh perspective on where she wants to take the organization going forward and you have the perfect recipe for success."

#### **Leaving a Strong Foundation**

Melissa stepped into the role with years of experience and mentorship from Leah.

"Leah's mentorship has meant the world to me, and I wouldn't be where I am today without her guidance," Melissa said.

Leah was CASA Jeffco/Gilpin's first employee in 2000, first volunteer in 2001, and then became Executive Director in 2005.

"Leah took this organization from a very small non-profit, struggling to fund the programs necessary to serve our children, to a well-funded and efficiently run nonprofit with an engaged donor base capable of providing a full range of services," said Laurie. "Without Leah's passion, determination, and ingenuity, none of this would have been possible."

When reflecting on her tenure at CASA, Leah highlighted the following:

- Our commitment to our community and always looking for ways to fill gaps and serve in the ways needed.
- Our decision to expand our services to help emancipating foster youth through our Youth Alliance programming at AVi.
- Developing the strong partnerships and relationships with our stakeholders, donors, volunteers, and supporters that have helped us have the reputation we have.

Leah is excited to have a shorter todo list in retirement. She also looks forward to seeing how the organization makes the necessary changes to best meet the needs of children in our community.

### **LEARNING TO THRIVE - YOUTH ALLIANCE**

Jeremy Chavez hasn't had an easy life, but you wouldn't know it if you met him. Positive, kind, compassionate, eager to help—Jeremy is determined to lead a meaningful life and inspire others. Jeremy was connected with CASA when he was 11 years old. He found his groove two years later when John Maxfield became his CASA volunteer.

"He's made all the difference in my life," Jeremy said. "He has been a guiding light—he's shown me how a man should act by just seeing how he operates. He's made me want to give back and share my story."

John and Jeremy continued their relationship when Jeremy joined Youth Alliance, CASA Jeffco/Gilpin's program to support youth emancipating from foster care, to help ease the transition to a healthy and self-sufficient adulthood. Jeremy recently completed the YA Program Completion Fund (PCF), a financial incentive program for any YA participant who is working toward financial independence. He's using his funds to pay down the debt on his truck, as he works to establish enough credit to purchase his first home.

"The most remarkable thing about Jeremy is not that he's smart, resilient, and determined (all of which he is), it's that he's compassionate, even for people in the face of betrayal," John said. "I've seen him be betrayed by people who should have been the closest to him. He never wanted to inflict trauma or pain back on people. I saw that in different shades throughout my involvement with him. I found it remarkable."

For children and youth uncertain about CASA or YA, Jeremy shared, "Not everyone can see outside their world. Look out and accept that help; take advantage of all the resources that CASA and Youth Alliance can give them. I took advantage of everything they could give me. Be open-minded and accept help."

Jeremy is thriving as a self-contracted insurance consultant. Jeremy and John plan to remain lifelong friends and text or talk regularly.



Jan joined the board in December 2000, serving as board chair for most of her tenure.


